Dr Nobs Mwanda, the CEO and founder of COPESSA, won the 2011 Shoprite Checkers Women of the year award, in the 'Good Neighbours against Crime' category, in recognition of her innovative approach to the child abuse scourge.

Our services are offered by a multi-disciplinary team, which is comprised of Psychologists, Social Workers, medical doctors, auxiliary social workers, lay-counsellors and volunteers. There are five full-time and three part-time staff members, and ten volunteers in our team. We give counselling and medical assistance to about 350 victims of abuse every year.
